After nearly 25 years in operation, The Catholic Community Foundation can still surprise people with our presence and our impact: more than \$22 million in grants awarded throughout the 10 counties we serve in Southeastern Wisconsin.

The Foundation focuses on Catholic causes and those that enhance education, leadership development, health care for the underserved, and community-building. Through cost-effective, socially responsible investment management, carefully considered grants, and ongoing monitoring, the Foundation and our donors support a wide range of charitable organizations. Meanwhile, our professional investment services help parishes and other Catholic agencies maintain long-term endowment growth to secure their futures.

At our fiscal year-end, Foundation donor and agency assets totaled \$175.5 million. Grant awards, made from donor assets, totaled \$2.36 million in fiscal 2024/25 and more than \$22.7 million since our inception in 2001. The most recent recipients are listed starting on page 10.

As a not-for-profit 501(c)(3) corporation, the Foundation is independent of the Archdiocese of Milwaukee. Our board of directors includes Catholic religious and community leaders. With our donors, we sustain and advance Catholic values and the Church's mission here in Southeastern Wisconsin.

Tony Nguyen brings deep financial expertise, experience as a board member, and personal knowledge of the life-changing impact of charitable giving to his work as president of The Catholic Community Foundation.

A native Iowan, Tony worked "a really good 21 years" with Wells Fargo, rising to be consumer banking regional executive for Wisconsin, Eastern Minnesota and Chicago.

"I started as a teller in college and saw the impact a banker could have on people's lives," he says.

And making a difference is important to him. Tony's parents came to Des Moines as refugees from Vietnam. "Both my parents were Catholic, which is how my brothers and I ended up named after saints—Anthony, Augustino and Francis," he says.

His father died when Tony was 9, and the kindness and support of parish and community members played a part in the family's healing. "One of my fondest memories is that there was always someone there to lend a helping hand," he says. "There's always been a connection to faith, to God. My mother raised three boys, never missed a beat, and we never missed a Mass. She made sure we stayed connected to our faith not just through her words, but through her actions."

Tony's responsibilities at Wells Fargo included getting involved in community organizations. At the suggestion of a coworker, he met with Mary Ellen Markowski, then president of the Foundation, and Dave Morris, who was chairman of the board. "They were interested in my banking expertise and in connecting with a younger demographic," he says. In 2017 he became a board member.



In 2024, Wells Fargo went through a reorganization. If he wanted to stay in banking, Tony would have to consider moving. But after 11 years, he and his family—Arin, his wife; Maddy, 14; Johnny, 12; and Zach, 10—had solid roots in Wisconsin.

"I had several lunches with Mary Ellen, who said she was getting ready to retire," Tony says. "She asked me to consider the Foundation. After some other opportunities that just didn't feel right at the time, this role kept coming back into the mix. She told me, 'I always thought you would replace me.'"

Tony took over the reins in April 2025 and, like Mary Ellen, seeks to guide the Foundation to have a broad impact on the faith community. "We want to keep growing our donor base so we can say yes to more grant requests," he says. "We also provide investment services for parishes in the archdiocese, following United States Catholic Conference of Bishops guidelines. I'd like to be the trusted partner for all of the parishes."

He's also looking at the granular details of Foundation operations, such as making grant distributions more efficient, sharing our stories on social media, and accepting donations through services that make it easy for people to give. Above all, he wants to further awareness of the Foundation's impact.

"We've given more than \$22 million in grants in the 10 counties we serve," Tony says. "The Foundation is making a difference! I want people to know about all the good the Foundation has done—and be part of all the good we'll be doing." ■

When Kathleen and Tom Huevler volunteer, they go all out — be it organizing dozens of golfers to partner with Special Olympics tournament participants (Kathleen), or baking hundreds of cookies to thank priests and others who serve the community (Tom).



“If I sign up, I’m here for you,” Kathleen says. Tom confirms that “she’s very intense, very thorough.”

And the Huevlers are impressed at how The Catholic Community Foundation is thoroughly here for others. “I can’t stress enough how much the Foundation gives back to the community,” Kathleen says. “The impact is mind-boggling.”

Yet the Huevlers hadn’t heard of the Foundation until their financial advisor, Dave Morris—then chairman of the Foundation board—invited them to the annual reception. Kathleen, a CPA who at the time was finance manager for The ALS Association in Wisconsin, put on her nonprofit hat for a closer look.

“I grabbed an annual report, and wow!” she says. The more she learned, the more she was impressed. “The Foundation is so well run. Everything just ticks along like a clock.”

By 2019, Dave had persuaded Kathleen to join the Foundation’s board. Tom was all for it. “I know her, I know her work ethic,” he says. “She’s the best at anything she volunteers for.” Today Kathleen continues as a board member, having served on the finance, grants, and development committees.



supporting children and families

Now working part-time as a job coach for people with disabilities, Kathleen also contributes time and talent to organizations including Family Promise of Ozaukee County, Sojourner Family Peace Center, and the Ozaukee County Special Olympics—where she serves as head golf coach.

Tom, too, is a dedicated volunteer. By the end of his 35-year career with Meurer Bakery, owned by Kathleen’s family, he was an expert in wholesale accounts, logistics and shipping. That comes in

handy at Christmas, when he sends cookies to seminarians, priests, retired religious and others from Milwaukee to San Diego.

Tom also bakes for the Cathedral Center shelter for women and families and collects clothing for those in need through the Knights of Columbus. He and Kathleen are drivers for Meals on Wheels and active in their parish, Lumen Christi Catholic Church in Mequon.

Says Kathleen, “We believe in supporting organizations we know are hands-on, doing the right thing.” Which is where The Catholic Community Foundation comes in.

a sensible way to give

The Huevlers were updating their estate plan and realized that the Foundation supports nearly every organization they want to give to. “They’re all nonprofits, not necessarily Catholic but all aligned with our faith,” Kathleen says.

She and Tom decided to channel their giving through the Foundation via a donor-advised fund. “It made sense to have everything all in one place—to give now, and to be able to give in perpetuity,” Kathleen says. She adds that

the Foundation made the process painless. “People are often reluctant to make changes, but shifting our funds was so easy. Just a couple forms, a couple meetings, and it was done!”

And Kathleen recognizes the power of pooled investments for the two groups the Foundation serves: organizations that carry out Catholic values here in Southeastern Wisconsin, and the parishes, schools and other Catholic agencies for whom the Foundation provides professional investment services.

“Every time I sit in a grants committee meeting, I’m amazed at how great the need is, and at how often we say ‘yes,’” she says. “Then I look at how parishes can benefit as part of the mix, and it’s incredible.”

spreading the word

The Huevlers agree that more people need to know the Foundation is here.

Says Tom, “We’d never heard of the Foundation until Dave brought it into our lives. It’s a wonderful organization that helps us now, and will still be here for us after we are gone.”

Adds Kathleen, “The more we can tell people about what the Foundation does, the more people will give, and the more good we can do.”

“And that,” says Tom, “will make everybody happy.” ■

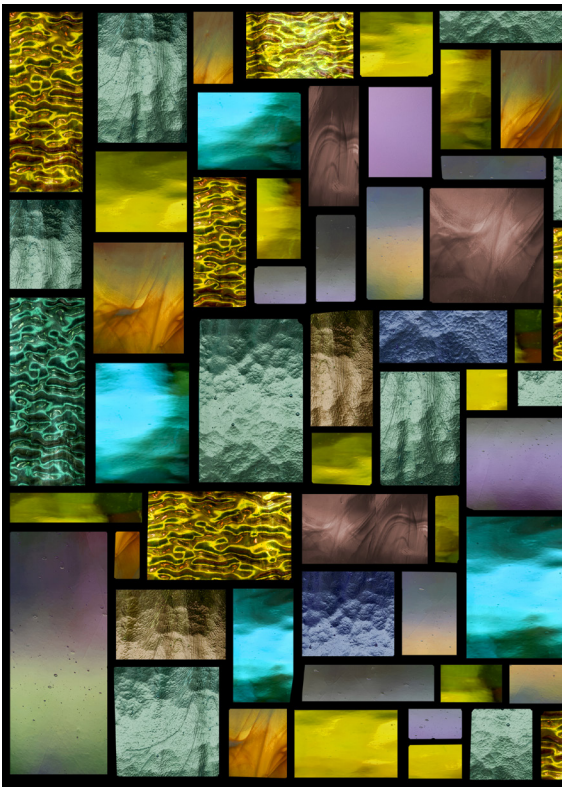

estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, revenues and expenses, and the disclosures of contingent assets and liabilities at the date of financial statements. Actual results could differ from these estimates.

tax-exempt status

The Foundation is exempt from federal and state income taxes on related exempt function income under Section 501(c)(3) of the Internal Revenue Code and has been classified as an organization other than a private foundation.

agency endowment funds

Certain Catholic parishes and other organizations have transferred funds to the Foundation for management. These funds are invested with the other funds of the Foundation, but title is retained by the transferring organization and the funds are reflected in the statements of financial position of the Foundation as investments and the corresponding amounts listed as current and long-term liabilities.

net assets

Net assets, revenues, gains and losses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, net assets of the Foundation are classified and reported as follows:

NET ASSETS WITHOUT DONOR RESTRICTIONS

Net assets that are not subject to donor-imposed stipulation. The governing board has designated, from assets without donor restrictions, net assets for purposes of maintaining field of interest, unrestricted, donor-advised and donor-designated funds in perpetuity.

NET ASSETS WITH DONOR RESTRICTIONS

Net assets subject to donor (or certain grantor) imposed restrictions. Some donor-imposed restrictions are temporary in nature, such as those that will be met by the passage of time or by actions of the Foundation pursuant to those stipulations prescribed by the donor. Other donor-imposed restrictions are perpetual in nature, where the donor stipulates that resources be maintained in perpetuity. Donor-imposed restrictions are released when a restriction expires, that is, when the stipulated time has elapsed, when the stipulated purpose for which the resource was restricted has been fulfilled, or both. The Foundation had no net assets with donor restrictions required to be maintained in perpetuity during the years ended June 30, 2025 and 2024.

The Catholic Community Foundation is audited annually. Copies of the complete audit reports are available upon request.
